Our finances are stable. Our fees have stayed the same since 2018 except when we offered a reduction during Covid.

The fortnightly Gibber Gabber newsletters continue to keep the membership informed of new classes, guest speakers, events, etc.

#### Some changes in the past year:

We have moved from Bridges Restaurant as a venue to Allwood House.

We have introduced some new physically active classes.

We now offer lots of events ie. Christmas dinner, mini Expo, morning teas, tutor meetings, trivia, Eltham Little Theatre and sausage sizzles.

### Future challenges:

- 1. To find new ways of engaging with Eltham Council.
- 2. To continue to attract new tutors.
- 3. To revitalise our activities in Northern Nillumbik, including securing one or more 'homes'.

Guy thanked the many volunteers and known contributors (307) including the tutors, office, kitchen volunteers and committee, with special thanks to Judy Vizzari (creative), Sue Lloyd (welfare) and Tony Lee (IT).
